53/19 DECLARATIONS OF INTEREST

55/19 PROGRESS ON ACTION TAKEN

Future High Street Fund

The Clerk informed the committee that Ryde had been unsuccessful in the Future High Street Fund bid, which Newport had won. The Clerk highlighted that he had been advised by a Member of Ryde Town Council that the Regeneration Team at the Isle of Wight Council had assisted in preparing Newport's bid.

Ryde High Street Pedestrianisation

The Clerk informed the committee that the consultation for the Pedestrianisation is ongoing and that there are currently many comments in favour of this.

Councillor Conyers informed the committee that she had attended a Local Access Forum meeting at which it was mentioned that the Government are currently planning to close unprotected railway crossings. This includes 14 on the Isle of Wight, 1 of which is in Ryde, raising queries with regard to the Nicholson Road track.

Councillor Lilley highlighted that at a recent Ryde Society meeting, Councillor Stuart discussed green spaces in Ryde and the concern of sites that are allocated for housing development within the new Island Plan. Councillor Lilley suggested that the Town Council should be encouraging protection of green spaces and should not wait until the Island Plan has been finalised.

The committee noted and welcomed the change of parking designation from duel use to a 1-hour restriction for cars in Victoria Street.

65/19 EMAIL REGARDING PLANNING APPLICATION P/00146/19

The Chair asked for the contents of the email submitted by a resident to be noted by committee and Cllr Lilley moved that there should be a discussion about this email. A vote was taken and Cllr Lilley's motion was carried. Cllr Lilley outlined his position with regards his own personal response to the planning application P/00146/19 and the restrictions that the planning committee may have in submitting an informed response. The Clerk informed the meeting that the response to the application from the planning committee was appropriate given the available information and the lack of comment from local residents. During discussions the email was not referred to again and the Chair then decided to move on to the next agenda item.

66/19 FEASABILITY STUDY FOR RYDE THEATRE

The committee noted the feasibility study for Ryde Theatre which was produced by the Empty Buildings Working Group and sent to the Town Council. The ideas presented for changing the theatre into a multi-use centre were welcomed and the Town Council look forward to any further work aimed at bringing the Ryde Theatre back into use. Some members of the committee were surprised that RTC was being mentioned, in the study, as a possible freeholder without any discussion being held with RTC.

67/19 PUBLIC REALM BUDGET APPLICATIONS

The committee considered a Public Realm Application in respect of flags at Ryde Harbour from Cllr Whittle who was not in attendance. The Clerk stated that he

had only received the application a few hours earlier and pointed out to the committee that there seemed to be some issues with the application which would need further investigation with the IW Council, who are responsible for harbour flags, so that an informed decision can be made. these issues include the potential sale of the harbour and its future ownership, the size of the flags, the possible need for planning approval and the fact that any public realm funding application over £1,500.00 would need to be referred to Full Council for a decision.

RESOLVED – The committee agreed to defer discussion on this application until the next meeting so that further information can be obtained from the IW Council.
