08/2018	Belvedere Street	Ryde	Request for disabled bay to be covered by order
103/2018	Binstead Road	Ryde	Area of verge is used for enforcement van to park. It has become very muddy.
107/2013	Smallbrook Lane	Ryde	Customer requests 'horse signs' to alert motorists.
11/2017	Ashey Road	Ryde	Customer has requested for a 20mph speed limit to be implemented
111/2016	Union Street	Ryde	cust would like to discuss the possibility of extending the pavement outside the shop to accommodate tables and chairs
113/2018	Maybrick Road	Ryde	Because posts have been put in on sherbourne avenue people are now parking in this road and churning up the grass and the verges and parking on the pavement causing a mess. Is there anything that can be done to deter this?
115/2017	Verwood Drive	Binstead	It is becoming more and more dangerous to pull out of Verwood Drive onto Newnham Road, especially when turning right due to lack of visibility caused by vehicles regularly parking close to the junction, often almost on the junction on the eastern side (Verwood drive) side of Newnham Road. This is further compounded by vehicles parked opposite the junction on the western side of the road. As more and more motorists ignore the advice of the highway code regarding not parking opposite a junction nor within 25 yards (aprox. 20 meters) of a junction it becomes ""OK"" to park anywhere unless there are yellow lines, and often these are wilfully ignored. Notwithstanding this, can active consideration be given to controlling parking at this junction by way of double yellow lines on both sides of the road. Couple all of this with the increased use of the road by H.G.Vs due to the recent location of Reynolds and Reed on the old Brickfields site and I hope you will appreciate that the matter is now of great concern. I have witnessed a number of ""near miss's.""
13/2016	Salters Road	Ryde	Continuous parking in the turning area at the end of Salters Rd, where if there are cars parked there then you have to reverse all the way back up the rd, which is long and not very wide either. Would like to see if there can be double yellow lines.
130/2017	George Street	Ryde	There is a disabled bay as the care home that they paid the Council for approx 5 years ago. People without blue badges keep parking in it - one man, in particular is very aggressive when asked to move and claims that it is only enforceable with an official sign next to it. Do we think that we could recommend a sign in this location?
135/2016	Cothey Way	Ryde	I feel it would be incredibly beneficial to have a stop at the junction to Cothey Way as the next stop is Tesco and in bad weather its not a horrible walk along the busy road. This would be on the existing route so I feel there would be very little trouble to add this in. I am not the only bus user who works on Cothey Way and feel it would be a valued addition to your services.
138/2016	St Thomas Street	Ryde	Customer says motorists are going up the pavement as driving round the corner and there have been 2 near misses in the last 24 hours. Customer says there is a bollard but believes this is in wrong place as cars get impatient waiting for vehicles coming in other direction so mount pavement then drive up road accordingly. customer is happy to meet someone on site to show personnel where she is on about if necessary.
140/2014	Cothey Way	Ryde	Workers from the factory nearby have started using this road to park on and they park right up to the junction, causing an obstruction and is very dangerous for residents trying to turn into the road. There have been several near misses
148/2016	High Park Road	Ryde	Customer concerned about cars parked near to the junction with Alexandra Road
15/2014	Belvedere Street	Ryde	The customer contacted Island Roads regarding parking at the Melville Street end of Belvedere Street. He advises that there are 3 old doctors parking bays on Belvedere Street that were previously used by the Doctors Surgery that moved over 10 years ago to Tower House. He is concerned that cars park in this area and as a result there is insufficient vision at the junction. Please can Island Roads look into the option of yellow lines at this junction as requested by the enquirer, provide their recommendations to the Contract Management Team, and add their findings to the Network Integrity and Improvement Register.
150/2014	West Street	Ryde	request bus stops for Ryde School.
153/2014	West Hill Road	Ryde	Can you please include this request for double yellow lines in the next review of the Ryde traffic order. Accidents have occurred pulling out of private driveways, due to obscured vision and speeding vehicles.
158/2017	Marlborough Road	Ryde	Customer has concerns regarding visibility at Long Orchard. Reduced visibility is due to parked vehicles
168/2018	Jellicoe Road	Binstead	Grass verge damaged by constant use of parking by vehicles on junction from Jellicoe road into Jellicoe close,traffic bollard also been damaged/ broken and missing for months. Replacement of traffic bollard and repair of grass verge requested to try and discourage the constant obstruction of the road,URGENT double yellow lines leading from Jellicoe road into Jellicoe close need to be extended further , no emergency vehicles would be able to gain access to culdesac Jellicoe close or rear of properties in the vicinity if a parked car on road/grass verge is obstructing.Residents believe Urgent issue to be reviewed by Island roads for the safety of all residents.Island roads staff member on duty working repairs Jellicoe road on Monday 16/4/18 advised I contact to report as soon as possible,staff too agreed with concern that no larger vehicle such as Fire Service would be able to gain access if vehicles continue to obstruct entrance into Jellicoe Close.

173/2018	Beatrice Close	Ryde	a mobility scooter user finds it impossible to drive it at the end of the close as vehicles keep parking on the pavement. The cars belong to a local resident and she has asked them not to park on the pavement but they told her that there is nowhere else that they can park. Can we advise anything to alleviate this problem?
174/2017	Ashey Road	Ryde	Customer called to put in a request for double yellow lines to be painted from the Wray Street junction with Ashey Road to the junction with Leighwood Close as cars park along the road right up to the junction restricting visibility. customer said it's even worse out of hours.

183/2014	Reed Street	Ryde	Since the new housing estates have been built, there have a reduction of the amount of available parking spaces. There is also a shop nearby for which people also park. There are cars parking on this road that do not belong to residents and the residents are struggling to find parking spaces. There are several cars that have been there for several weeks without moving. Customer wants to ask if residents permit parking can be introduced? Please contact customer with any information.
188/2015	Park Road	Ryde	The parking at the entrance to Holly Tree Close is becoming dangerous. Put double yellow lines on the junction of Park Road and Holly Tree Close to improve visibility.
190/2016	Anglesea Street	Ryde	The customer has asked if IR can install a bollard or some other device to stop speeding vehicles entering Anglesea Street from the High Street. caller has said on two occasions he has almost been hit by a speeding vehicle.
191/2015	Buckingham Close	Ryde	There are Dyl at the junction and the turning circle but not in the middle. The road is only 4.9m wide and vehicles park on both sides often on the pavement. DYL required to manage the highway in this location.
196/2017	Wellington Road	Ryde	customer complains about cars parking on the grass verges and on the pavement says something needs to be done
202/2018	Rink Road	Ryde	Request for double yellow lines
209/2016	Church Road	Binstead	would like us to consider traffic calming measures on this road as it getting exceedingly difficult with increased traffic & parking. resident puts cones out to 'reserve' parking which adds to the congestion near the junction
209/2018	Esplanade	Ryde	Request for measures to prevent vehicles turning right
210/2014	West Hill Road	Ryde	I have written before (Isle of Wight council) about the dangerous roads the children in my area have to cross to get to school but I never get a reply. The children going to St Marys Primary school and Oakfield in Ryde have to cross either the dangerous roads of St Johns hill, Alexandra road and the dangerous junction of Alexandra road and West hill road. These roads between 8 and 9am are very busy and have no crossing patrol or zebra crossings unlike crossings on route to other schools on the isle. For example Going to Dover park school Where there is a zebra and two lollipop ladies. We have one lollipop man on the safest road of all, High park road and of course the crossings directly at the schools. If you need to cross either way at the top of st Johns hill, Near Orchard gardens it is very dangerous for an adult let alone a small child. The cars, often late for work come fast down and up the hill. Buses, parked vans obscure views and lorries come tanking down the hill. Trying to cross Alexandra road near the Old Oakfield school is impossible to do with any safety at all especially from where all try to cross, near the junction with St Johns Hill. That junction has no island either. Some cars do not indicate coming down from St Johns church way and fly up Alexandra road junction with st Johns. Why do these two very busy and dangerous roads have no safe place to cross? Now for West hill. If you attempt to cross from Alexandra rd on the left towards the schools you cannot see what is coming up west hill from the left. The road is nearly completely obscured by a massive hedge. Some cars do not indicate either. Crossing from on the supposed safe sticking out island on the return from St marys school on west hill at the top
210/2016	Esplanade	Ryde	As a resident and bus user I am surprised to find a lack of bicycle racks at key transport hubs. In particular at Ryde Bus station where there is also the interchange with the railway and catermaran. Today I cycled in to use the bus to Newport and had to chain my bike to railings and hope that it will still be there when I return later. Please could you put some racks in as it will encourage people to use this healthy form of transport and there are financial incentives and grants for the installation of bike racks.
213/2017	Simeon Street	Ryde	Request for bollards to be placed to prevent overrun by large vehicles
214/2017	Rink Road	Ryde	Request for double yellow lines on southern side of road
219/2017	Queens Road	Ryde	Mrs Reeves said that, over the last few months, she's seen a couple of people heading from Binstead to Ryde (on Queens Road) driving on the wrong side of the road. She asked if there's anything we can put on the road to indicate that it's not a dual carriageway.
233/2017	Binstead Hill	Binstead	Customer has difficulty crossing the road at the western end of Binstead Hill. Requesting improvements
24/2017	Buckingham Close	Ryde	Buckingham Close is very narrow and like many surrounding roads, suffers from commuters parking all day to avoid paying at the car parks. There are some double yellow lines, but the middle section has none either side and people have taken to parking on both sides at once. This means that the gap in the centre of the road is not wide enough for today's larger cars, and certainly no ambulances etc.
248/2017	Newnham Road	Binstead	would like to comment on lack of yellow lines outside the entrance to mountain ash car park newnham road binstead, nearly always there is a vehicle (normally a van) parked, which makes visibility on leaving the driveway very difficult and I think it's an accident waiting to happen.
250/2017	Upton Road	Ryde	Hello Thank you for the information regarding the upgrade of Upton Rd This seems like an opportune time to enquire about the double yellow lines on both sides of Holmewood Close that we were assured would be in place by March 2013 - this came and went as did 2014 2015 2016 and march 2017 with no progress The egress from Holmewood Close is on to a busy road that is used by heavy lorries, horse riders cyclists (both children and adults) as well as walkers and school children - it is the only egress between Windmill Close and Ryde town that does not have double yellow lines on both sides - this is a very serious accident waiting to happen - It is often impossible to get out safely and people are at risk I am writing this note in the hope that you will consider this in the upgrade

251/2016	Sadlers Close	Ryde	The junction of Sadlers Close and High Park Road has no parking or waiting restrictions and is frequently cluttered with vehicles. All other junctions on High Park Road are protected with double yellow lines. Sadlers Close is narrow and thus vehicles parked close to the junction restrict both visibility and space. The proximity to schools means that there is a risk that children and other pedestrians are less likely to be seen. It also makes it very difficult for us as residents to see if the road is clear prior to emerging on to High Park Road and when returning to Sadlers Close. As well as a lack of double yellow lines, there are also no junction lines at all and this I feel may give the impression that Sadlers Close has less status than other public roads and therefore there is less risk when parking in the entrance. I have raised this issue before and have many photographs which prove my point.
259/2017	Upton Road	Ryde	residents in Holmewood Close, frequently experience considerable difficulty when driving from their road onto Upton Road, because the current yellow lines permit vehicles to park right up to our road's entrance, on the north (towards Ryde) side. Cars often park right up to the junction, thus blocking line of sight towards Ryde. Even worse are the numerous occasions when the parked vehicles are tall vans, and exiting our road becomes highly dangerous. One has to creep out into the remaining (southbound) carriageway with no idea of whether anything is coming from Ryde. Also, because of the "S" bend in Upton Road, traffic coming from Ryde towards Upton Cross cannot see any exiting vehicle from Holmewood Close (when vehicles are parked right up to our turning) until almost too late. A few years ago, an assurance was obtained from Highways that they would extend the double yellow lines in Upton Road, in order to deter vehicles parking right up to our turning, but unfortunately this work was never carried out. Could I please ask you to give consideration to addressing this matter during your forthcoming works, as you will of course be undertaking the reinstatement of yellow lines and other road markings upon completion of the resurfacing?
280/2017	(blank)	Ryde	Ryde 20mph - could Ryde east be a pilot scheme?
284/2017	Elm Close	Ryde	I am pleased that the much needed improvements to Elm Close, Ryde are underway and would like to congratulate the men on their hard work and helpfulness to the residents. However, I would hate to see this work to be done in vain if no steps are taken to prevent heavy vehicles visiting the Close to continue to be forced to mount the pavement because of inconsiderate permanent parking all down one side of the entry road. This has already resulted in damage to the existing concrete paths and will no doubt decimate the tarmac which is being used to replace it. Now would be the appropriate time to extend the double yellow lines down both sides of the close to prevent future damage to the footpaths and kerbs. In addition to the damage to the pavements, a more important issue is that of safety. It is impossible to see any vehicles leaving the Close when approaching to make a left turn into the Close. There have been many occasions when a car has been forced to reverse back into the very busy Great Preston Road and many near misses! This is extremely dangerous for pedestrians especially children on their way to and from school
289/2017	Grange Ave / Winston Ave	Ryde	1) Can the double yellow lines be extended around the bend and down the hill section of Winston Avenue?
291/2017	Appley Road	Ryde	I was delighted to read your Look Local Newsletter and particularly to read about your walk around the area with Island Roads. We take our lives in our hands every time we try to cross Appley Road to get to Puckpool Hill and the park. It is especially tricky with grandchildren in tow. So, any help there is very welcome. The double bends at Calthorpe Road are difficult. We often meet vehicles driving on the wrong side of the road as they drive too quickly and the holes in the hedging where the riding stables are bear the scars of previous accidents. I would also like to draw your attention to another danger point, just beyond the double bend at the start of Calthorpe Road at the 3rd bend near the Woodvale Close junction. There is a frequent squeal of brakes as traffic from Seaview hit the first bend and sometimes miss. A few weeks ago we had 2 cars written off there. The first was a speeding car that lost control and ploughed on and off the bank eventually hitting a field gate, destroying several boundary posts and placing the street light in a front garden. Thankfully there were no cars in the field that day. The second was a lady who overturned her car and landed in the middle of the road. Thankfully both drivers were unhurt. There is a 'SLOW' sign painted on the road near Woodvale Close, but it is too late. I have emailed Island Roads, but never had a response, so I am probably ignored. Perhaps you could draw this section of road to their attention? A road sign warning of 'Bends' would be helpful, but both those drivers I mentioned were local, so that is probably not going to help much. I think an earlier SLOW sign and perhaps starting the 30mph limit sooner might slow a few more drivers coming from Seaview.

292/2017	Monkton Street	Ryde	Delivery vehicles mounting pavement outside customers property.
294/2017	Grenville Driver	Ryde	caller life is becoming increasingly problematic, especially in the evenings. Cars are parking around the junctions which is causing problems when vehicles need to pull out. Customer will take photos and send them to info@islandroads
295/2016	Bullen Cross	Ryde	the junction at bullen cross has become very dangerous due to the speed of traffic coming from calthorpe rd towards pondwell hill, they cut the corner so if you are walking to go to oakhill rd after leaving the no8 bus pedestrians are in danger of being struck by a vehicle. i myself have had some very close misses, i think it is a spot just waiting for a serious accident to happen. i hope you will be able to monitor the junction and see for yourself what a dangerous junction this is. i look forward to favourable response to this request.
297/2015	Kent Street	Ryde	Limited turning area at end of cul-de-sac in Kent St. Photos attached. Customer requesting lining / c/w markings to prevent parking & obstructions for vehicles, pedestrians and access to off street car park
300/2016	Leighwood Close	Ryde	no DYL on the junction cars have to swing out and it is becoming dangerous for pedestrians as well as vehicles

301/2017	Bullen Road	Ryde	Thank you for writing to us about the work to be carried out from 27 July between Marlborough Road and Pondwell Hill, Ryde. Whilst you are carrying out the work we would be more than delighted to have a marked shared pedestrian/cyclist lane in Bullen Road so that we can walk or cycle more safely towards Pondwell and up to the traffic lights at Westridge Cross from Swaylands Close. Is there a chance it could be included please? We are new Isle of Wight residents and we are delighted and impressed by the improvements made to the road network across the Island so far.
302/2016	North Walk	Ryde	I have received a few complaints regarding cyclists that are going to the left hand side of these railings, as you can see it is very close to the concession cafe there; I fear an accident could happen here, and also I've been told there have been a few 'near misses' with bikes and walkers. Do you think some signs could be arranged for cyclists to keep to the right side of these railings by perhaps signs or painting words/imagine on floor at either end? Would this be something you would consider please?
303/2017	West Street	Ryde	Customer was nearly run over this morning and there had been 9 cats run over so far this year. Customer says that 30mph speed limit is abused and he wants to talk to someone in authority that knows what can be done to resolve this ongoing disaster waiting to happen
308/2017	Arthur Street	Ryde	Request for vehicle activated sign to be installed
309/2017	Parkway	Binstead	I see the kerb is broken again and I saw with my own eyes the recycling truck mount it in a sudden manoeuvre, not to get past the car but to swing round and reverse up Conniston Avenue. The cars are always there at recycling time as it coincides with the school run. Double yellow lines are needed
312/2016	Esplanade	Ryde	Customer would like a formal DB outside her flat as the parking areas are always taken up.
317/2016	Hayward Avenue	Ryde	When exiting on to Marlborough Road it is not possible to pull into a kerbside position when encountering a vehicle entering the Avenue at the same time. This is because of the siting of the existing yellow lines. Effectively, in these circumstances, one is left driving on the wrong side of the road directly in the path of the vehicle entering the road. Commonly the above results in having to reverse back down the Avenue for several car lengths. The distance involved is somewhat further than desirable in a residential area. The road space available is very limited resulting in the reversing vehicle being rather too close to the opposite pavement and any pedestrians happening to be using it.
317/2017	Binstead Lodge Road	Binstead	removal of advisory disabled parking bay and addition of double yellow lines for easier access onto private drive
319/2016	Pitts Lane	Binstead	Comment regarding lack of footway on this road
321/2017	Swanmore Road	Ryde	Also, on Swanmore Road, there are DYLS. residents have been complaining about the lack of parking anywhere near there. He wonders whether we can have one or two spaces for vehicles made available on this road
33/2016	Appley Road	Ryde	Request for pedestrian crossing
330/2014	Playstreet Lane	Ryde	Playstreet Lane in Ryde is a narrow lane, restricted in width for most of its length with a 20mph speed limit and speed bumps. For most of that restricted width stretch it has double yellow lines on both sides of the road to prevent obstruction. However there are a couple of short stretches with double yellow lines on one side only. This has not historically been a problem until recently. The former Haylands Primary School which closed two or three years ago has now been taken over by Ryde Academy which backs onto the other side of the site and whose main access is via Pell Lane. The Haylands School was reopened in January as a sixth form centre for Ryde Academy. Students with cars are not allowed to use the Haylands Car Park and are meant to use the dedicated car park in the main Ryde Academy site. However some students have discovered that it is easier and quicker to park in Playstreet Lane, where there are now several student cars and motorbikes parked all day on every school day. This causes an obstruction for local residents who have difficulty in entering and exiting driveways, but also for larger vehicles such as refuse lorries, which have difficulty in passing. I believe that this is causing a safety hazard. I would therefore like to request that the double yellow lines are extended on both sides of Playstreet Lane for the whole stretch with restricted width in order to prevent this obstruction.
337/2014	Buckingham Close	Ryde	There are now yellow lines in my road which keeps it a lot clearer for larger vehicles, such as those used in the weekly waste collections. However because part of the road has no yellow lines either side we still have the occasional "bright spark" that parks on the pavement blocking it, the road and exit from the drive opposite (see attached photo). I understand that blocking the pavement is not illegal these days but what about reducing the highway's width? May I suggest the easiest way of sorting out this occasional problem is to extend the double-yellow lines along the whole of the road's south side.
339/2014	Buckingham Close	Ryde	I understand a resident in Buckingham Close, Ryde has contacted you with a request for parking to be prohibited on the south side of the road. I would like to support this request, as there are occasions when it would not be possible for an emergency vehicle to pass.
339/2016	The Strand	Ryde	cust is asking for a blue badge sign to be placed on his disabled parking bay
343/2017	St Johns Wood Road	Ryde	Customer called to say that there is currently yellow line with a TRO sign in the area but people park there at all times and even up on the pavements making access along the road difficult and obstructing visibility when exiting the terrace. He wants to know if double yellow lines would be possible to deter people.

370/2015	St Johns Hill	Ryde	I have written before (Isle of Wight council) about the dangerous roads the children in my area have to cross to get to school but I never get anywhere with my requests. I am forwarding this message to other organisations so please do reply to me or put some pressure on to get some action. (No offence I.O.W council) Do not assume the Isle of Wight council will do anything. After years of writing they have done nothing yet. The children going to and from St Marys Primary school and Oakfield school in Ryde, and catching the buses to other island schools on the Isle of Wight have to cross either the busy and dangerous roads of St Johns Hill (near the top) or Alexandra road. It is this Junction area which is the main problem, not further up near the schools or further down St Johns Hill. This is a walk to school route, with one path which disappears but has no speed reductions, crossings, crossing patrols, crossing islands or even signs to say children crossing! Cars and trucks nearly always exceed the 30 limit, drivers are on phones, overtaking parked cars and stopped buses. Drivers do not even slow down when the kids are crossing. I hear mums and dads shouting at the kids daily to either stop or run! Trying to cross Alexandra road at the junction of St Johns Hill for the kids going to Oakfield school is impossible to do with any safety at all. That junction has no island either and some cars do not indicate at all when turning at the junction so the kids are really risking it all crossing. This is a very busy area with bends, trees and parked cars, buses, articulated lorries and fast cars. It is unfair to expect children to have to cross these roads without even any signs to warn drivers of them crossing. Please can we at least have some signs to warn the drivers of kids crossing and to slow down. I can't believe that I have asked the council to look into this matter so many times for years and nothing has ever been done. Not even coming to look.
372/2016	Buckingham Close	Ryde	It is becoming an increasing problem within Buckingham Close of visitors parking on the left hand pavement causing an obstruction for residents and their vehicles. This is not an isolated incident photographed over this weekend but an occurrence at least twice a week. We are finding that we have to either use our horn to locate the car owners or abandon our own vehicle to knock on doors to get them to remove the obstruction. Should the emergency services need urgent access, this parking in a tight close, would cause a major problem. We are asking if you would consider extending the yellow lines along the left hand side of the close, which will hopefully eradicate the problem.
379/2014	Cothey Way	Ryde	There are a lot of factories along this road & despite them having car parks vehicles still park along the kerb, very close to the junction. This makes it dangerous to pull in or out without meeting something trying to pass parked cars or having the view blocked. Can we consider yellow lines?
383/2015	Pellhurst Road	Ryde	Customer would like to have seating at the bus stop outside the clinic on Pellhurst Rd. She said sometimes you have to wait 3/4 of an hour. There aren't any spare seats that you can use within the clinic and she said it would be really helpful to people to have seats at this bus stop.
384/2017	Quarry Road	Ryde	Customer has requested if DYLS can be considered for this location to match up with existing DYLS lines already either side of the junction.
385/2016	Newnham Road	Binstead	The stables have a concealed entrance and people are often having near misses coming out onto the road. Can anything be done to make this safer? Due to two blind bends north and south of Pencombe House and the equestrian centre they have explained difficulties when exiting the two properties. Perhaps additional signage and slow markings can be considered.
387/2017	Bettesworth Road	Ryde	Bettesworth Road has recently become busier & noisier. But more worryingly is the increase of people driving along the road at dangerously high speeds. It's cars & motorbikes @ all times of the day. The end of the road where the school is has a few flashing school signs but it's further down the road where they tend to pick up speed. It's almost as if it's on a racing circuit as some cars fly down & then come round again! Something needs to be done as it's a busy residential road with a school, parked cars all the way along one side & many elderly people & also lots of cats that belong to the residents of the road. I'm sick of hearing people wheel spinning, skidding & accelerating excessively as it's only a matter of time before there is a serious accident. The road is clearly used as a cut through and drivers just bomb through with no regard for residents or kids walking to school etc
394/2017	Beech Grove	Ryde	Customer is concerned that vehicles park right on the corner of Beech Grove, junction w/ Spencer Road, and cause poor visibility when trying to drive on to Spencer Road. She asked if we can take action on this, like painting DYLS on the section of Beech Grove to prevent people parking there.
40/2017	Broadway Crescent	Ryde	Request for additional double yellow lines as poor parking is blocking buses
412/2016	Marlborough Road	Ryde	Customer states that more DYLS are needed in Marlborough Road outside of Long Orchard

452/2014	West Hill Road	Ryde	I have written before (Isle of Wight council) about the dangerous roads the children in my area have to cross to get to school but I never get a reply.The children going to St Marys Primary school and Oakfield in Ryde have to cross either the dangerous roads of St Johns hill, Alexandra road and the dangerous junction of Alexandra road and West hill road. These roads between 8 and 9am are very busy and have no crossing patrol or zebra crossings. We have one lollipop man on the safest road of all, High park road and of course the crossings directly at the schools. I have spent allot of time looking and walking these routes over the years so I know what I am talking about. If you need to cross either way at the top of st Johns hill, Near Orchard gardens it is very dangerous for an adult let alone a small child. The cars, often late for work come fast down and up the hill. Buses, parked vans obscure views and lorries come tanking down the hill. I never ever let my son cross alone even if he is old enough. Trying to cross Alexandra road near the Old Oakfield school is impossible to do with any safety at all especially from where all try to cross, near the junction with St Johns Hill. That junction has no island either. Some cars do not indicate coming down from St Johns church way and fly up Alexandra road junction with St Johns at 30mph at least without slowing down. Why do these two very busy and dangerous roads have no safe place to cross? Now for West hill. If you attempt to cross from Alexandra rd on the left towards the schools you cannot see what is coming up west hill from the left. The road is nearly completely obscured by a massive hedge. Some cars do not indicate either. Crossing from on the supposed safe sticking out island on the return from St marys school on west hill at the top, towards Alexandra it is highly dangerous as many cars and vans completely block the view even for an adult, down West Hill on the right.
