Reasons: The proposed advertisements, because of their position and size, would be intrusive and visually prominent additions to the street scene which would appear incongruous and would be out of character with this area. By virtue of the residential nature of the surrounding area, including the general lack of advertisements, the signs proposed would represent an unnecessary form of clutter within the street scene. The proposal is therefore contrary to policy DM2 (Design Quality for New Development) of the Island Plan Core Strategy. Ryde Town Council objected to this proposal on the grounds that the signs will detract from the character of the area in accordance with the principles of DM2. The signs are of such a size and nature that they do not respect the area and would be more appropriate in a town centre urban location.

The proposal, by reason of its siting within the designated woodland and in proximity to the ancient semi-natural woodland, would result in direct and in-direct impacts on trees, to the detriment of the woodland and its designation. The proposal would also result in the introduction of built form into the wooded environment which would be contrary to the established landscape character at this point, which would be contrary to the site, the designated woodland, and the wider landscape character which is identified as being an Area of Outstanding Natural Beauty . The proposals would also increase the potential for future pressure on the woodland, and ancient semi-natural woodland. As such, the proposals would be contrary to policies SP5 (Environment), DM2 (Design Quality) and DM12 (Landscape, Seascape, Biodiversity & Geodiversity) of the Island Plan, as well as being contrary to the National Planning Policy Framework (principle 11 - Conserving the Natural Environment) in particular paragraph 118

The application contains insufficient information relating to the assessment of impacts upon ecological features and species (in particular bats) that would result from the development, as such, the proposals fail to have sufficient regard to the protection of features and species of ecological importance and are therefore considered contrary to policies SP5 (Environment) and DM12 (Landscape, Seascape, Biodiversity & Geodiversity) of the Island Plan, as well as being contrary to the National Planning Policy Framework (principle 11 - Conserving the Natural Environment) in particular paragraph 118.
