#### **ISLAND ROADS**

Notice is hereby given that the Isle of Wight Council in not less than seven days from the appearance of this Notice, under Section 14 (1) (a) of the Road Traffic Regulation Act 1984, proposes to make the following Orders: -

### The Isle of Wight Council (Alexandra Road, Ryde, Isle of Wight) (Temporary Prohibition of Through Traffic) Order No 2 2019

Island Roads on behalf of The Isle of Wight Council give notice that for four days and nights between approx. 0900 on Monday 29 July 2019 until 1600 hours on Friday 2 August 2019, or when the works have been completed, no person shall cause any vehicle, to proceed along Alexandra Road, between its junctions with St Johns Hill and Appley Road. The alternative route will be signposted locally. The closure is required for safety during carriageway repairs.

# The Isle of Wight Council (Chilton Lane, Brighstone, Isle of Wight) (Temporary Prohibition of Through Traffic) Order No 1 2019

Island Roads on behalf of The Isle of Wight Council give notice that for one day between approx. 0900 and 1600 hours from Monday 29 July 2019 until Friday 2 August 2019, or when the works have been completed, no person shall cause any vehicle, to proceed along Chilton Lane, between its junctions with Hoxall Lane and Fleetway. The alternative route will be signposted locally. The closure is required for safety during barrier works.

# The Isle of Wight Council (Warlands Lane, Shalfleet, Isle of Wight) (Temporary Prohibition of **Through Traffic) Order No 4 2019**
